- Each vendor is responsible for setup and vendors must use only designated dumpsters for removal of trash.
- Setup begins at 6:00 am the morning of the event.
- No setup will be permitted after 8:00 am.
- You must maintain your booth until 3:00 pm. Dismantling your booth before closing time is not permitted and will eliminate you from participation the next year.
- No setup on or blockage of sidewalks is permitted.
- Our insurance does not cover you and you should have your own insurance coverage.
- Vendors are responsible for providing the State and City with tax information for income generated during the event.

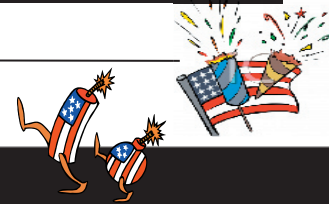

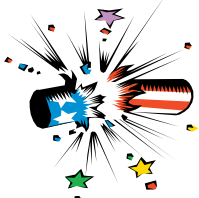
